1. Definition

A cookie is a small text file that can be placed on your device that allows us to recognise and remember you recording your browsing activity. It is sent to your browser and stored on your computer's hard drive or tablet or mobile device and then retransmit to the same websites the next time you visit.

A cookie cannot be used to personally identify a user, who remains anonymous.

2. What we do

When you visit our sites or when you use our apps, we may collect personal data from you automatically using cookies or similar technology.

The purpose of cookies is to notify us when you visit our website. As such, they are only used in order to improve the personalised service that we provide to you.

The statistics generated by cookies allow us to determine the level of traffic to our website, as well as the most frequently visited pages. They are necessary for us to provide our services, and are solely intended to improve our offerings. The Website uses *technical cookies*. Such cookies, due to the technical nature, do not require the prior consent of the User to be installed and used.

However the user has the option to prevent the generation of cookies and disposal of the same by selecting the appropriate option in your browser.

3. How to configure cookies

You may review your choices at any time and disable some or all of the cookies that we use, directly via our website.

4. Configuring your web browser

You can configure your own browser to automatically refuse cookies. However, some features of the site may no longer be accessible if you choose this option. If this occurs, under no circumstances can we be held responsible.

6. Cookies we use

In particular, the cookies used on the Website are traceable to the following subcategories:

9. Social Plugins of Facebook, Instagram and Linkedin

Social plug-ins are small pieces of software which create a link between your visit to our Website and the social media platform of a Third Party Provider. The social plug-in will let the Third Party Provider know that you have visited our Website and may let the Third Party Provider receive cookies he has placed on your computer beforehand.

When you visit our pages, the plug-in establishes a direct connection between your browser and the providers server. Providers receives the information that you have visited our site with your IP address.

The content of the respective Plugin will then be directly transmitted to your browser by the associated provider and integrated into the website. Integration of the plugins gives the providers the information that your browser has called up the corresponding site of our internet offer, even if you do not have any profile with the corresponding provider or are not currently logged in. This information (including your Internet Protocol address) will be submitted directly to a server of the respective provider in the USA or UE by your browser and stored there.

If you are logged into a social network, the providers may assign your visit of our website directly to your profile on Facebook, Instagram or LinkedIn. If you interact with the Plugins, e.g. by pushing the "Like" or "Connect", the corresponding information will also be directly transmitted to a server of the provider and stored there. The information will also be published in the social network or on your social account and indicated in your contact details there.

Note that we have no control over how these social plug-ins work, the data that they collect or what the Third Party Provider does with this information.

10. Facebook Pixel

Facebook pixels are small pieces of software and are nearly invisible pixel-sized "dots" on our Website which create a link between your visit to our Website and Facebook. When the pixel loads, Facebook places a so-called "fr"-cookie on your computer, which helps Facebook to provide you with more personalized advertisements, but also to measure and improve advertisements. 11. YouTube

Our website include plug-in from YouTube of Google, LLC, 901 Cherry Ave., San Bruno, CA 94066, USA and integrates YouTube videos.

The embedded clips store cookies on the user's computer when the page is accessed. If you have deactivated the setting of cookies for the Google advertising program, you will not have to reckon with such cookies when you access YouTube clips. YouTube also stores non-personal usage information in other cookies. If you want to prevent this, you must have the browser block this.
